## SUMMARY OF PUBLIC INVOLVEMENT ACTIVITIES

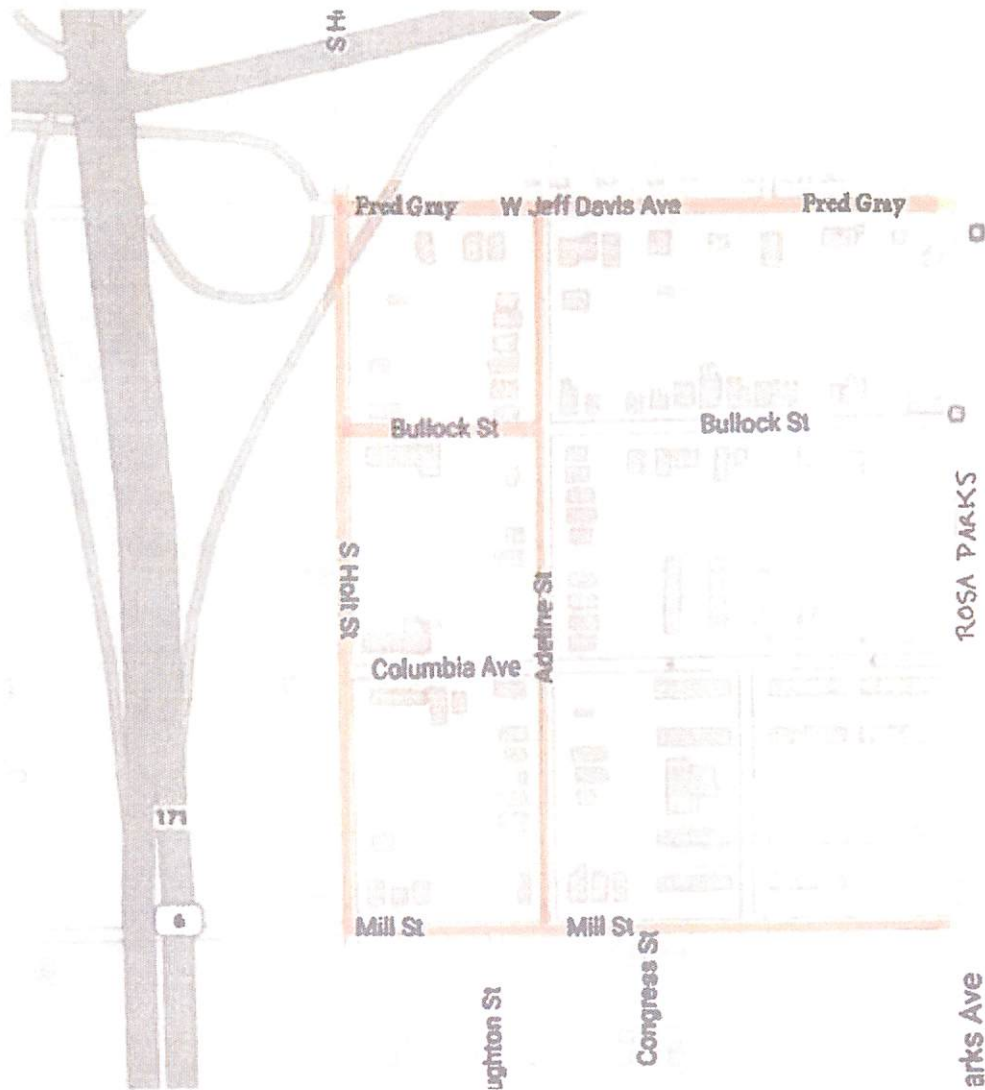

**Holt Street Neighborhood Proposal  
to the  
Montgomery Metropolitan Planning Organization  
Transportation Improvement Program (TIP) FY 2024-2027**

**Project Description:** Resurface, add/repair sidewalks from Fred Gray at Holt Street to Rosa Parks and Fred Gray at Holt Street to Mill Street; Mill Street at Holt Street to Rosa Parks; Fred Gray at Adeline Street to Mill Street; and Bullock Street at Holt Street to Adeline Street.



The Holt Street Baptist Church Historical Society, on behalf of itself and the citizens living in west Montgomery, do request consideration of inclusion of this proposed request to resurface, add/repair sidewalks, and enhance a section of the Civil Rights Trail, as well as a section of west Montgomery.

The Society was created to maintain the Holt Street Baptist Church structure as a museum and historic site for, among others, the purpose of preserving the history of the church, its role in the Montgomery Bus Boycott and the movement that the Boycott spawned. This building was the site of the first mass meeting that launched the Montgomery Bus Boycott on December 5, 1955, and for the Boycott's duration that continued serving as the primary meeting place for strategic planning sessions as well as other mass meetings.

The Museum has received city residents and tourist from other states as well as foreign countries. Our visitors, drive, ride tourism buses, ride bicycles, and some have even walked from downtown Montgomery hotels. The City of Montgomery has many transportation options for traveling visitors and city residents, which supports and enriches the City's economic vitality, safety, and security. We believe that additional investments should be made in west Montgomery to increase accessibility and mobility of its citizens and tourist that are now coming to see all of Montgomery's historical sites.

Commissioner Sankey - MPO Member Sankey:

Email comments received. I will share your comments with the Montgomery MPO members of which you are a voting member of. I will also share your comments with the City of Montgomery Engineering Department and Public Works Department about the Froggy Bottom bridge and the requested need for sidewalks. As we discussed about the bridge replacement project, the City Engineering Department has determined that the bridge is not structurally deficient or functionally obsolete and will not replace it at this time. They did say that the bridge is narrow but that vehicles can pass in each direction. They said they will post a sign in each direction before reaching the bridge that says that the bridge is narrow and also install guard rails on it. Further, all of Wares Ferry Road has been resurfaced from Atlanta Hwy to McLemore Road with the City and County splitting the cost to get the resurfacing done to totally complete the project.

There is federal funding available that the MPO has that can be used for sidewalk projects. There are funds under the Transportation Alternative Program (TAP) and the Carbon Reduction Program funds. Also regular MPO dedicated funds can be used for sidewalk projects. It is a matter of conversations with the City agreeing to fund projects with both 80% federal funds and 20% local match and a cost estimate on what it will take to get those things done.

I agree with you that citizen participation is important. We take multiple approaches and attempts to getting citizen participation in the transportation process. Those ways include: MPO Citizens Advisory Committee (CAC), Public Notices in the local general circulation newspaper (Montgomery Advertiser), the MPO internet website (Montgomerympo.com) and email distribution of the public notice, comment forms, summary of project funds for the TIP and comment forms to the Neighborhood Association Presidents via the Neighborhood Services Department at the City and the conduct of public involvement meetings which is held at a central location, which is at the City of Montgomery's Intermodal Transportation Facility in the Conference Room, which is central place that is accessible for people with disabilities and accessible via our public transit system's central point for all bus routes. Please let me know about the particular groups that you mention and we will invite them to future efforts for plans and programs. We have attempted in the past to do just that but have never gotten significant attendance. All meetings that the MPO or any advisory committee has are open to the public.

Your recommendation about an equity committee should be brought forth to the rest of the MPO Policy board membership to get that created. Just an FYI there is a great deal of federal funds that comes to the ALDOT/State of Alabama that can be accessed, but there is a 20% local city or county match that has to be agreed to pay to obtain the funds in addition to federal grant applications. I have copied City Engineering and Public Works Staffers for their information about your comments on the Froggy Bottom Bridge and sidewalk needs along Wares Ferry Road.

One thing to keep in mind, the TIP is a living document and can be changed with amendments as we do several times each fiscal year.

Greetings Mr. Robert Smith

I am responding to your outreach effort to get citizens involved in commenting on the Transportation Improvement Plan (TIP) for 2024-2027.

I have spoken with the some of the citizens that live along Waresferry Road in Montgomery Alabama in regards to the 2 Bridges that need an upgrade. We all agree that the Froggy Bottom Bridge is in poor condition and certainly represents a potential safety hazard for pedestrians and motorists alike. Aside from being in poor condition, the bridge is too narrow. In addition, there are no sidewalks or any area that would provide some means for crossing the bridge on foot. The replacement of this bridge should be included in the TIP for 2024.

Also, citizen participation is an important part of our transportation program and should be a process that is truly inclusive. In order to achieve this objective the MPO should arrange to have better community outreach. This could be accomplished by having public hearings in traditionally underrepresented communities, reaching out to low income groups, minorities, persons with disabilities, and the elderly. The data on the percentage of people participating in the public hearing by coming to the Intermodal Transportation Facility should be reviewed for statistical significance.

An additional recommendation that I would put forth, is to establish an Equity Committee within the MPO. This committee would be responsible for identifying funding sources at the Federal level that are available to address surface transportation challenges in our service area, with a special focus on traditionally underserved and historically disadvantaged communities. We are missing the opportunity to identify funding that could be used to address deferred maintenance within our transportation network.

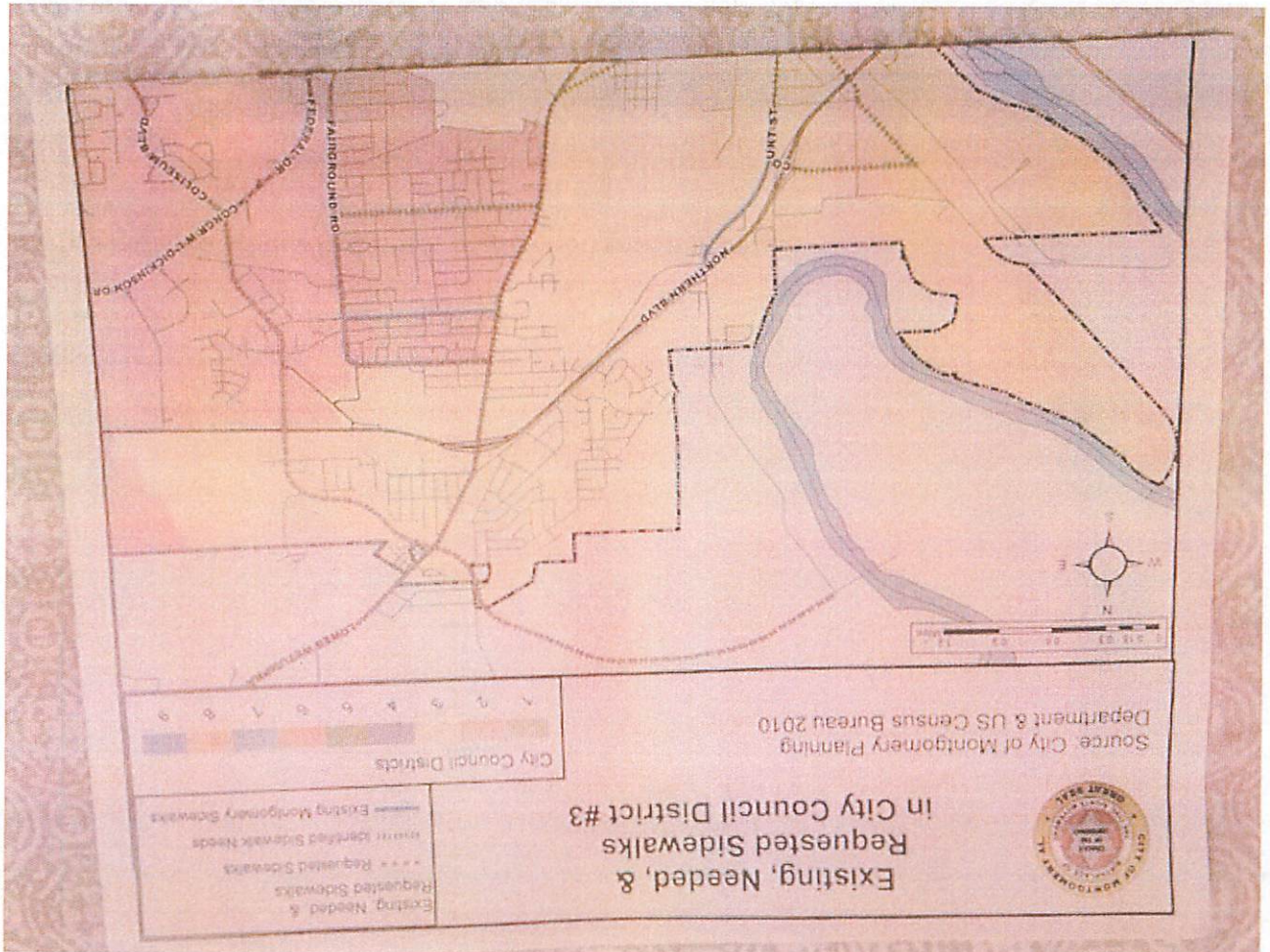

There is a school patrol officer located @ the intersection of Lower Wetumpka Rd. & Michigan Ave. to aid in safe crossing but the other areas of Lower Wetumpka Rd. from Broadway street up to the railroad track @ the corner of the old Brockway Glass Co. is a dangerous trek for all pedestrian but especially for the children for whom we consider to be our future.

There have been @ least 3 children over the years struck riding their bicycles along Lower Wetumpka Rd.

As per your inquiry concerning the provision of sidewalks along Lower Wetumpka Road, we are pleased to announce that this roadway will be included in the upcoming Montgomery Metropolitan Planning Organization (MPO) Bicycle and Pedestrian Plan. This plan seeks to improve the bicycle and pedestrian network throughout the Montgomery Planning Organization coverage area, including portions of Autauga, Elmore and Montgomery.

To provide an enjoyable and efficient network for pedestrians and cyclists in the Montgomery area, the MPO staff has graded each proposed bicycle route and sidewalk on a number of criteria. These criteria include access to schools, proximity to points of interest, connectivity to transit and existing sidewalks, and other factors measuring the relative safety of pedestrians. To ensure that municipal dollars are well spent, it is important to dedicate funds where they will be most productive. This includes repairing existing sidewalks, providing safe and comfortable routes to school and creating a network that connects parks, historic districts and civic amenities.

To facilitate the implementation of the Bicycle and Pedestrian Plan, longer segments have been divided into several shorter segments. For example, Lower Wetumpka has been identified as a roadway in need of sidewalks along both sides from Decatur Street to Alabama River Parkway. This stretch of road, more than two and a half miles, has been divided into four sections with breakpoints at Gibson Street, Chisholm Street and Northern Boulevard. While each of these segments scored differently based upon the criteria stated above, all segments were near the median score.

As the Plan enters its final stages, each segment will be categorized as Priority 1, Priority 2, Priority 3, or Long Range. Funds have not yet been allocated, nor requested for the vast majority of these routes or segments. The Metropolitan Planning Organization will review the Draft plan in the next month, and then the plan will be available for public comment. The public comment period will be your opportunity to voice your concerns and perhaps impact the prioritization of these segments. The public comment period will be advertised. Please make plans to have your voice heard.

We thank you for your concern and look forward to working with you in the future.
