At the regularly scheduled meeting of the Technical Advisory Committee (TAC) on September 8, 2016 at 10 a.m. at the City of Montgomery Intermodal Transfer Facility in the conference room, 495 Molton Street, Montgomery, AL 36104, the aforementioned members were present. The meeting was called to order at 10:06 a.m. by Mr. Kindell Anderson

Agenda Item 2: Mr. Anderson announced that a quorum was present, with 12 voting members present.

Agenda Item 3: Introduction of Guest: Mr. Jeff Feet a member of the Montgomery Bicycle Club. Agenda Item 4: Minutes from the previous TAC Meeting, (Action Item): There were no corrections or revisions to the minutes, a motion was made by Mr. Bowden to adopt the minutes, and seconded by Mr. Beyer, therefore the agenda item passed unanimously and without any further discussion.

Agenda Item 5: FY 2016-2019 (TIP) Amendments: Mr. Anderson provided an update about the projects.

- Page 2: (TAP) Project: For Pratt Street from East Main Street to Water Street in the City of Prattville; Downtown pedestrian path improvements. The funding source Transportation Alternative Program (TAP) Funds; the federal match will cover \$178,744 and local match \$44,686 total cost \$223,430.
- Page 3: A State of Alabama project for Resurfacing and 2" Safety Widening on SR-14 from the Eastern City Limits of Autaugaville to SR-6(US-82). A distance of 9.33 miles, the funding source Surface Transportation Any Area/Highway Safety Improvements (STPAA/HSIP) Funds. The federal match will cover \$2,232,072 and local match \$558,018 total cost \$2,790,090(STPAA). The federal match will cover \$627,770 and local match \$69,752 total cost \$697,532. (HSIP).
- Page 4: The State of Alabama project for Resurfacing and 2" Safety Widening on SR-6(US-82) from just east of SR-14 to SR-3 (US-31); a distance of 2.60 miles. The funding source will be National Highway System / Highway Safety Improvement (NHS/HSIP) Funds. The federal match will \$1,038,497 local match \$259,624 total cost \$1,298,121(NHS). The federal match will cover \$292,453 and local match \$32,453 total cost \$324,530 (HSIP).

After discussing the TIP Amendment projects and all projects are in balance; Mr. Beyer made a motion to adopt the FY 2016-2019 Projects, and Mr. Duke seconded the motion. Therefore the agenda item passed unanimously and without any further discussion.

Agenda Item 6: Final FY -2017 Unified Planning and Work Program:

- \$510,346 in Federal Highway and Federal Transit Administration Planning (PL)Federal Funds Only (includes \$80,000 for consulting assistance for the City of Montgomery and \$32,000 for the City of Wetumpka
- Total FY-2017 Final UPWP budget estimate is \$637,926 with Local Match being \$127,585 (includes \$140,000 for consulting assistance for the City of Montgomery Bike and Pedestrian Plan update and \$40,000 for the City of Wetumpka Land Use and Transportation consultants).
- Federal Transit Administration (FTA) Section 5303 Planning Funds have been combined with Federal Highway Administration Planning Funds to be one 1 fund for better management.
- Funds pay for 5 full-time staff person's salaries, planning and programming work related to required documents, MPO administration and other federal requirements, general operating costs for meetings, advertising for meetings, public hearings and various other activities.
- \$140,000 total dollars (\$112,000 federal/\$28,000 local) in consulting assistance for FY-2017. Updated Bicycle and Pedestrian Plan for the City of Montgomery; Land Use and Transportation consultants for the City of Wetumpka Comprehensive Plan.

- Fiscal Years 2016-2019 Transportation Improvement Program (TIP) will be maintained and amended as needed.
- Various other transportation planning duties such as, prior year authorized projects list report and advertisement, overall GIS database update and maintenance and other associated GIS work related to planning and programming activities, traffic count updates, report writing, grant writing, etc.

The Final Fiscal Year (FY) 2017 Unified Planning work program (UPWP) Budget Highlight Summary were discussed, a motion was made Mr. Bowden and seconded by Mr. Robison; therefore the agenda item passed unanimously and without any further discussion.

Agenda Item 7: Draft MATS 2017 Transit Development Plan: See attached Summary page. (Bowden made the motion with changes to the plan, Miller seconded)

Agenda Item 8: Transportation Alternatives Program (TAP) Projects

The Montgomery Metropolitan Planning Organization (MPO) receives a direct annual allocation for the Transportation Alternatives Program (TAP) for \$415,413. The responsibility for reviewing the TAP applications submitted to the MPO rests with the Montgomery MPO Bicycle and Pedestrian Subcommittee (BPS). One application was received from the Town of Pike Road in the second call for projects utilizing the FY 2016 allocation. The approval of this project will leave \$48,819 as carryover to FY 2017.

- Town of Pike Road Project: will construct the 3rd part of the Pike Road Multi-Purpose Trail on Wallahatchee Road. This application is to fund an approximately 0.75 mile long section from Phase 2 to a potential residential development and town center. The trail will be approximately six feet wide. The total project cost is estimated to be \$234,813.00. The Town of Pike Road is requesting \$187,850.00 from the Transportation Alternatives Program to be matched by \$46,963.00 of local funds.
- The BPS was sent the TAP Project information as well as a recommendation form on August 5th. (The following recommendation was approved by the BPS:

(Fully fund the Town of Pike Road Project).

A motion was made by Mr. Miller and seconded by Mr. Duke to adopt the agenda item, the agenda item passed unanimously and without any further discussion.

Agenda Item 9: Transportation Project Status (ALDOT) (Tyler Ashmore)

- I-85 Resurfacing from Hall Street to North of Ann Street, worked completed, punch list items
- Service Road Improvements along SR-6 (US-82/US-231) Near Trenholm State College, scheduled to be complete October 2016.
- I-65 Resurfacing from South of US-31 Interchange (MP 186) to (CR-61 (MP 190), added shoulder work, scheduled to be complete October 2016.
- I-65 Resurfacing from Elmore County Line (MP181.5) to South of US-31 (MP186), added shoulder work, scheduled to be complete October 2016

- SR-126 Resurfacing and Safety Widening from Atlanta Hwy to Chantilly Parkway, worked completed, punch list items being work on.
- SR-293 Resurfacing and Safety Widening from SR-110 to SR-126, worked completed, punch lists items being work on.
- Resurfacing US-82 (Troy Highway) from the Eastern Bypass to Taylor Road, signal work remaining scheduled to be complete October 2016.
- Resurfacing I-85 from East of Ann Street to West of SR-8 (US-80) Eastern Boulevard, work began in May 2016, scheduled to be complete January 2017.
- Resurfacing I-65 from Pintala Creek to Catoma Creek, added shoulder work, scheduled to be completed October 2016.
- Bridge replacement on US-80 @ Pintlala Creek, Traffic detoured, old bridge removed, scheduled to be complete March 2017.
- Montgomery Outer Loop Lighting project, 6 months for procurement beginning June 2016.
- Traffic and Pedestrian improvements on Ann Street at I-85, 180 day procurement.
- Intersection improvements and bridge replacement on SR-14 @ SR-143, Pre-Con September 8, 2016.
- Bridge replacement on SR-14 over Beaver and Ivy Creeks, letting was September 30, 2016.

Agenda Item 10: Any Other Issues/Business/Concerns:

- On all projects, per Mr. Bollie make sure the contractors, work is being done according to the construction contract.
- The consultant selection process is being done at the Local Region Bureau of ALDOT.
- T & A Review process being change with new guidelines from FHWA.
- Bicycle and Pedestrian Plan update RFP will soon be advertised.


