Agenda Item 4: Minutes from the previous CAC meeting (Action): Minutes from the previous CAC Meeting Mrs. Campbell made the motion to adopt and accept the minutes from the previous CAC; following a second by Mr. Donaldson. Therefore the agenda item passed unanimously and without any further discussion.

Agenda Item 5: FY 2020-2023 TIP Amendments (Action Item): Mr. Smith provided the CAC Members details about the TIP Amendment Projects.

 Page 2: State of Alabama Project for 2-Year Regional Traffic Operations Program (RTOP) TSMO For 118 Signalized Intersection along SR- 6 SR-8 SR-9 SR14 SR 110 SR-271 US 231 and Cobbs Ford Road in the Cities of Montgomery Prattville Millbrook and Wetumpka FY-23-FY 24. Intelligent Transportation Systems (ITS). The Funding Source will be Regional Traffic Operations Program (RTOP) TSMO. Total federal cost is \$779,624, State match \$194,906 Total Funds \$974,530.

- Page 3: A Montgomery County Commission project for Resurfacing on Wasden Road (CR-15) From the Lowndes County Line to Lamar Road (CR-15); Site 2 Resurfacing on Lamar Road (CR-15) From Wasden Road (CR-15) To SR-8 (US-80). A distance of 2.8 Miles Site1 & 2.9 Miles Site 2; the funding source MPO Dedicated STPMN Funds. The Federal Funds will cover \$1,260,000 Local Match \$315,000 Total Funds \$1,575,000. (This project was originally programmed into the adopted TIP but was never put into the ALDOT project management system and given a project number. It was originally 2 separate projects in original TIP and is now combined. ALDOT wants it reapproved so that construction can begin in August 2022.
- Page 4: A City of Montgomery project for Resurfacing, traffic signal improvements and sidewalks upgrades on Wares Ferry Road from Eastern Blvd to the Froggy Bottom Bridge Phase #2. A distance of 1.6 miles; the funding source will be MPO Dedicated Surface Transportation Program Maintenance Program Funds. The Federal Funds will cover \$2,772,419 Local Match \$693,105 Total Funds \$3,465,524. (This project is proposed to be moved in from FY-2023 to FY-2024. This project is also proposed to be increased due to increased construction costs. The original cost was \$2,600,000 in federal funds and the new cost estimate is \$2,772,419 in federal funds.
- Federal cost increase is \$372,419 in MPO dedicated funds. Old total cost was \$3,250,000 and new total cost is \$3,465,524. It is slated for the August 2022 letting for construction.
- Page 5: A City of Montgomery project for resurfacing, curb, and gutter, inlet conversion, traffic striping and sidewalks on Federal Drive from Atlanta Hwy to CSX Railroad Crossing; a distance of 2.1 miles. The funding source MPO Dedicated Surface Transportation Program Maintenance Program Funds. The federal fund match will cover \$3,280,000 Local Match \$820,000 Total funds \$4,100,000. This project is proposed to be moved in from FY-2023 to FY-2024. This project is also proposed to be increased due to increased construction costs. The original cost was \$2,400,000 in federal funds and the new cost estimate is \$3,280,000 in federal funds. Federal cost increase is \$880,000 in MPO dedicated funds. Old total cost was \$3,000,000 and new total cost is \$4,100,000. It is slated for the August 2022 letting for construction.
- Page 6: A Montgomery County Commission for resurfacing Hobbie Road from Sprague Junction to US-331 (SR-9); a distance of 9.3 miles. The funding source will be MPO Dedicated Surface Transportation Program Maintenance Program Funds. The federal funds will cover \$1,304,000 Local Match \$326,000 Total funds \$1,630,000. This project was originally included in the original FY 2020-2023 TIP, however the ALDOT has asked for a new MPO resolution approving of this project since it was never given an official project number. No changes have been made to the projects scope or cost since it was originally approved in the original TIP adopted in September 2019. Needs to be reapproved.
- Page 7: A State of Alabama project for Adding a Lane on SR-14 from 0.5 miles west of CR-3 (Ingram Road) to CR-153 (Coosada Pkwy. The funding source Surface Transportation Program Any Area. The federal funds will cover \$4,800,000 State Match \$1,200,000 Total Funds \$6,000,000.(This is a cost increase going from \$964,921 total dollars to \$6,000,000 total dollars, Old federal dollar amount was \$771,937 with \$192,984 in state match. New federal dollar amount is \$4,800,000 and new state match is \$1,200,000. Cost increase is due to updated estimate for water utility relocation.

- Page 8: State of Alabama project for Access Management Modification Along SR-3(US-31) from CR-4 to SR-6. The funding source will be National Highway System (NHS) Funds. Federal Funds will cover \$36,000, State Match \$9,000 Total Funds \$45,000
- Page 9: A State of Alabama project for Additional Lanes on SR-110 (Vaughn Road) from Chantilly Pkwy to CR-294 (Bridle Brook Boulevard); a distance of 1.0 miles. The funding source Surface Transportation Program Any Area Funds. The federal funds will cover \$155,259 State Match \$38,815 Total Funds \$194,074.
- Page 10: A City of Montgomery project for Widening, Level, Resurface and Traffic Stripe Zelda Road from Ann Street to Carter Hill Road; a distance of 2 miles. The funding source will be MPO Dedicated Surface Transportation Program Maintenance Program Funds. The federal fund will cover \$1,824,000 Local Match funds will cover \$456,000 total cost \$2,280,000. (This project is proposed to be moved out from FY- 2023 to FY-2024 in the new 2024-2027 TIP. It will not be ready for construction due to other scopes being completed.

After Mr. Smith reviewed and discussed the FY-2020-2023 TIP Amendment projects a motion was made by Mr. Donaldson to adopt and accept the current projects; following a second by Mr. Burnett. Therefore, the agenda item passed unanimously without any further discussion.

# Agenda Item 6: Draft FY-2023 UPWP Budget (Action Item)

Fiscal Year (FY) 2023 Unified Planning Work Program (UPWP) Budget Highlights Summary)

- \$629,886 in Federal Highway and Federal Transit Administration Planning (PL) Federal Funds only \$488,993 in FY 2023 funding (\$140,893 unused carry over funds from FY -2022 (FY2023Carry over)
- Total FY-2023 Final UPWP budget estimate is \$787,358 with \$629,886 federal and \$157,472 local match, funding includes two planning studies that started in FY-2022 with dollar amounts in consulting funds needed to complete projects.
- Two Municipalities will complete planning studies using UPWP carryover funds
  - a. City of Prattville (Bike Ped Plan-\$15,000 federal \$3,750 Local Match
  - b. City of Montgomery / The M Transit (Transit Development Plan: \$50,000 federal; \$12,500 local match) build in this fiscal year)
- Federal Transit Administration (FTA) Section 5303 Planning Funds have been combined with Federal Highway Administration Planning Funds to be 1 fund for better management
- Funds pay for 5 full-time staff person's salaries, planning and programming work related to required documents, MPO administration and other federal requirements, general operating costs for meetings, advertising for meetings, public hearings and various other activities.
- Fiscal Years 2020-2023 Transportation Improvement Program (TIP) will be amended as needed for FY-2023. A new FY 2024-2027 TIP will be prepared and adopted in FY -2023 before September 30, 2023.
- Various other transportation planning duties such as prior year authorized projects list report and advertisement, overall GIS database update and maintenance and other associated GIS work related to planning and programming activities, traffic count updates, report writing, grant writing, etc.

After the discussion of the UPWP Summary Highlights a motion was made by Mr. Reeves to adopt and accept the FY-2023 Budget for the UPWP; following a second by Mr. Burnett. Therefore, the agenda item passed unanimously and without any further discussion.

## Montgomery Metropolitan Planning Organization (MPO) Resolution Adopting The Draft Fiscal Year 2023 Unified Planning Work Program

WHEREAS, the Montgomery Metropolitan Planning Organization (MPO) is the organization designated by the Governor of the State of Alabama as being responsible, together with the State of Alabama, for implementing the applicable provisions of 23 USC 134 and 135 (amended by the FAST Act, Sections 1201 and 1202, December 2015); 42 USC 2000d-1, 7401; 23 CFR 450 and 500; 40 CFR 51 and 93; and

**WHEREAS** the U.S. Department of Transportation requires all urbanized areas, as established by the U.S. Bureau of the Census, doing area-wide urban transportation planning that involves more than one Department of Transportation operating administration, to submit a Unified Planning Work Program as a condition for meeting the provisions of Title 23, U.S. Code, Section 134; and,

WHEREAS consistent with the declaration of these provisions, the Montgomery Metropolitan Planning Organization Transportation Planning Staff, in cooperation with the Alabama Department of Transportation, has prepared an Amended Final Unified Planning Work Program for Fiscal Year 2022, amending the carryover dollar amount of \$423,566 that was approved on July 22, 2021 to the corrected dollar amount of \$200,374 with amendments to task 1.1 MPO Administration (increase from \$107,845 to \$170,345), task 5.3 Transit Planning and Administration (increase from \$150,980 to \$213,480 and task 5.6 (increase from \$5,000 to \$130,476); and,

WHEREAS pursuant to its duties, functions, and responsibilities, the Montgomery Metropolitan Planning Organization (MPO) on this the 21st Day of July 21, 2022, did review and evaluate the aforementioned Draft 2023 Unified Planning Work Program, summarized on the attached pages; now,

**THEREFORE BE IT RESOLVED** by the Montgomery Metropolitan Planning Organization (MPO) that the same does hereby endorse and adopt said Draft Fiscal Year 2023 Unified Planning Work Program as written.
