Montgomery Metropolitan Planning Organization (MPO) Transportation Meetings Announcement

The Montgomery Metropolitan Planning Organization (MPO) announces that several meetings will be held to consider proposed amendments to the **Fiscal Years (FY) 2012-2015 Transportation Improvement Program (TIP)** and discuss other business items. The following meetings are scheduled during September 2014:

Technical Coordinating Committee—The Technical Coordinating Committee (TCC) advises the MPO on the feasibility and technical aspects of proposed transportation projects. The TCC will meet on **Tuesday, September 16th, 2014 at 10:00 a.m.** at the Downtown Intermodal Transportation Facility, located at 495 Molton Street, Montgomery, AL 36104, in the Conference Room.

Citizens Advisory Committee—The Citizens Advisory Committee (CAC), the organized forum for local citizens involved in the transportation planning process, also advises the MPO. The CAC will meet **Tuesday, September 16th, 2014 at 2:00 p.m.** at the Downtown Intermodal Transportation Facility, located at 495 Molton Street, Montgomery, AL 36104, in the Conference Room.

Metropolitan Planning Organization—The Metropolitan Planning Organization (MPO) is the policy board of local elected and appointed officials responsible for approving transportation projects and setting transportation policy in the study area portion of the tri-county area, and for the adoption of the required transportation documents for the Montgomery Study Area. The MPO will meet on **Thursday, September 18th, 2014 at 11:30 a.m.** at the Montgomery Area Transit System Intermodal Facility Conference room located at 495 Molton St, Montgomery, AL 36104.

The proposed amendment transportation projects to be considered at each meeting for the **FY-2012-2015 Transportation Improvement Program (TIP)** are as follows:

1. **Project Number: IM-11-AM:** Bridge repair on I-65 southbound (relief bridges 6, 7, and 8). This project is for preliminary engineering. The engineering is a cost of \$20,000 dollars with \$18,000 dollars in federal funds and \$2,000 matching funds. The project sponsor is the State of Alabama.
2. **Project Number: IM-12-AM:** Bridge repair on I-65 northbound and southbound (relief bridges 4 and 5). This project is for preliminary engineering. The engineering is a cost of \$20,000 dollars with \$18,000 dollars in federal funds and \$2,000 matching funds. The project sponsor is the State of Alabama.
3. **Project Number: IM-13-AM:** Bridge repair on I-65 northbound and southbound (relief bridges 1, 2, 3, and 11). This project is for preliminary engineering. The engineering is a cost of \$20,000 dollars with \$18,000 dollars in federal funds and \$2,000 matching funds. The project sponsor is the State of Alabama.
4. **Project Number: EC-15-AM:** Bridge replacement on CR-79 (Mehearg Road) over Callaway Creek BIN#7575. This project is for construction. Construction is a cost of \$936,320 dollars with \$749,056 in federal funds and \$187,264 in matching funds. The project sponsor is the Elmore County Commission. This project is proposed to be moved from FY 2016 to FY 2015.
5. **Project Number: M-30-AM:** Resurface on South Perry St from Fairview Dr. to Arba St. This project is for construction. The construction is a total cost of \$1,406,080 dollars with \$1,124,864 in federal funds and \$281,216 in matching funds. The project sponsor is City of Montgomery. This project is proposed to be moved from FY14 to FY18.
6. **Project Number: M-31-AM:** Resurface East Fairview Ave from South Court St to Cloverdale Rd. This project is for utility. The utility is a total cost of \$100,000 dollars with \$80,000 in federal funds and \$20,000 in matching funds. The project sponsor is the City of Montgomery. This project is proposed to be moved from FY14 to FY18.
7. **Project Number: M-32-AM:** Bridge Painting on Various Structures in the City of Montgomery. This project is for construction. The construction is a total cost of \$250,000 dollars with \$200,000 in federal funds and \$50,000 in matching funds. The project sponsor is the City of Montgomery. Project is proposed to be moved from FY14 to FY18.
8. **Project Number: M-33-AM:** Resurface S. Court St from Fairview Ave to Southern Blvd. This project is for right of way. The right of way is a total cost of \$181,216 dollars with \$144,972 in federal funds and \$36,243 in matching funds. The project sponsor is the City of Montgomery. This is a cost reduction from \$281,216 to \$181,216.
9. **Project Number: M-34-AM:** Resurface Wares Ferry Rd from Atlanta Highway to Eastern Blvd. This project is preliminary engineering. The preliminary engineering is a total cost of \$100,000 dollars with \$80,000 in federal funds and \$20,000 in matching funds. The project sponsor is the City of Montgomery.
10. **Project Number: M-35-AM:** Advance Protective purchase of south east property of Perry Hill Road and Atlanta Highway (Flips) for Perry Hill Rd Phase II Project. This project is for right of way is a total cost of \$600,000 with \$480,000 in federal funds and \$120,000 in matching funds. The project sponsor is the City of Montgomery.
11. **Project Number: M-36-AM:** Resurface Various Street in Central Business District in Montgomery. This project is for construction. The construction is a total cost of \$4,334,573 with \$3,467,658 in federal funds and \$866,974 in matching funds. The project sponsor is the City of Montgomery. This is for a cost increase of \$607,313 due to cost overruns.

12. **Project Number: M-37-AM:** Resurface West Fairview Ave from South Court St to I-65. This project is for construction. The construction is a total cost of \$2,273,671 with \$1,818,963 in federal funds and \$454,734 in matching funds. The project sponsor is the City of Montgomery. This is for a cost increase of \$548,767 due to cost overruns.
13. **Project Number: W-3-AM:** Resurface, sidewalk improvements, landscaping and decorative lighting fixtures on S Main St from East Bridge St to US-231 (SR-9). This project is for construction. The construction is a total cost of \$500,000 with \$400,000 in federal funds and \$100,000 in matching funds. The project sponsor is the City of Wetumpka. Project is being split into two separate projects.
14. **Project Number: W-4-AM:** Resurfacing only Court St; E bridge from S Main St to Hill St; Resurface, sidewalk improvements, landscaping and decorative lighting fixtures on Company St from Hill St to Orlene St, Orlene St from Company St to Hill St and on Hill St from Orlene St to Company.. This project is for construction. The construction is a total cost of \$482,408 with \$385,926 in federal funds and \$96,481 in matching funds. The project sponsor is the City of Wetumpka.
