Agenda Item 2: A quorum assessment, with 10 voting members present and 2 proxy. The MPO Meeting began 11:43 A.M; called to order by MPO Chairman Mr. Jinright.

Agenda Item 4: Minutes from the Previous MPO Meeting (Action Item) Minutes from the previous MPO Meeting, a motion made by Mr. Stone to adopt and accept the minutes following a second by Mr. Singleton. Therefore the agenda item passed unanimously and without any further discussion

Agenda Item 5: FY 2020-2023 Montgomery MPO TIP Amendments; (Mr. Robert Smith)

- Page 2: An Elmore County Commission Project for Widening, Level, Resurface and Traffic Stripe Alabama River Pkwy from SR-143 to Jackson Lake Road; a distance of 1.57 miles. The funding source will be STPMN MPO Dedicated Funds. The Federal Funds will cover \$661,000 Local Match \$165,250 Total cost \$826, 250.**(Cost increase from \$857,500 Total Cost (\$686,000 federal and \$171,500 local match to \$982,500 Total Cost (786,000 federal and \$196,500 local match). Total Cost Increase \$125,000**
- Page 3: An Elmore County Commission State Project for Widen, Level, Resurface & Stripe Cobbs Ford Road from Edgewood Road to SR-143; total distance 1.31 miles. The Funding source will be STPMN MPO Dedicated Funds. The federal funds will cover \$1,200,000 Local Match \$300,000 Total Funds \$1,500,000.**Project proposed to be moved up from FY-2023 to FY-2022. No additional funds added to this. Deleted from FY-2023**
- Page 5: A City of Wetumpka project for Resurface and Sidewalk Improvements on South Main Street from East Bridge Street to US-231; a distance of 1 mile. The funding source STPMN MPO Dedicated Funds. The federal funds will cover \$94,579 local match \$23,645 Total funds \$118,224
This project is proposed to be deleted and will not be needed. Utility relocation federal funds programmed in FY -2022 are proposed to be deleted in the amount of \$94,579. The \$94,579 is proposed to be added to the construction project increasing the total project cost from \$800,000 (\$640,000 federal) to \$918,224 (\$734,539 federal). No additional federal funds requested.
- Page 6: A City of Wetumpka project for Resurface and Sidewalk Improvements; a distance of 1 mile. The funding source will be STPMN MPO Dedicated Funds. The federal funds will cover \$734,539 Local match \$183,645 Total funds \$918,224. **Utility relocation federal funds programmed in FY-2022 are proposed to be deleted in the amount of \$94,579. The \$94,579 is proposed to be added to the construction project increasing the total project cost from \$800,000 (\$640,000 federal) to \$918,224 (\$734,539 federal). No additional federal funds requested. (DELETING UTILITY)**
- Page 7: A State of Alabama (DOT) project for Intersection Modification at US-331 @ Hobbie Road. The funding source will be Highway Safety Improvement Program (HSIP). **For PE, the federal funds will cover \$13,500 State Match \$3,375 Total Funds \$16,875; CN Federal funds \$252,500 State Match \$63,125 Total \$315,625. Total \$266,000, Match \$66,500 & Total Funds \$322,500**
- Page 8: State of Alabama project for Resurface SR-110/ Vaughn Road from .37 miles west of SR-293/ Outer Loop top the Bullock County/ Montgomery County Line; a distance of 2 miles.

Agenda Item 6: Kick off for MPO Congestion Management Process Plan Update (Paul Gilliam)
Congestion Management Plan: Update the Congestion Management Plan in FY-2022. Mr. Gilliam gave an overview of the Congestion Management Plan Process. He said that his firm would start and complete travel time runs on major roadways as identified in the previous plan as a starting point and would get suggestions for other needed roadways. He said that they would summarize the MPO travel demand model posted speeds and congested speeds in the base year and forecast year also and compare. Lastly, he said that they will use the big data tool that ALDOT has acquired for work in the Congestion Management Plan update.


