Federal Highway Administration Federal Law requires Metropolitan Planning Organizations to publish a list of transportation projects that were authorized/obligated in the previous fiscal year that involved federal highway or transit funds. A project is considered authorized/obligated when a funding contract has been completed between the sponsoring local government or State government entity and the Alabama Department of Transportation. The authorized/obligated projects list includes those projects from the Montgomery area funded in fiscal year 2023. A fiscal year runs from October 1 to September 30 annually.
