Public Hearing Meeting and Comment Period on The Montgomery Metropolitan Planning Organization (MPO) Updated Draft *Public Participation Plan (PPP) Document*

Public Notice is hereby given that the Montgomery Metropolitan Planning Organization (MPO) will hold a Public Involvement Meeting and comment period concerning the **Updated Draft Public Participation Plan (PPP)** for the regional transportation planning process. The updated draft Public Participation Plan details federal guidelines which govern the transportation planning process and how the public can become involved in the transportation planning process. The *Public Participation Plan* also outlines the role of the Citizens Advisory Committee in the transportation planning process and includes a sign-up sheet for the Public Involvement Notification List. **Comments will be accepted from Friday July 25, 2025 to Monday, September 8, 2025, during the 45-day public comment period.**

A Public Hearing Meeting will be held on Monday, August 11, 2025 from 5:00 p.m. to 6 p.m. at the City of Montgomery Intermodal Transportation Center in the MPO Conference Room located at 495 Molton Street, Montgomery, AL 36104.

The Public Hearing Meeting format will be an open house format for the meeting. Attendance at the meeting is at your convenience. The Draft Updated Public Participation Plan will be available at the meeting as well as on the MPO website at <https://montgomerympo.org/public-involvement/>. Comment sheets will also be provided at the meeting, as well as on the MPO website listed above. Representatives from the City of Montgomery and MPO Transportation Planning Division will be available to answer questions during the meeting. The public involvement comment period will last for 45 days from July 25, 2025 to August 8, 2025.
